## Aims of the Research Policy

They also endeavour to make sure that the institution research activities conform with all applicable rules, regulations, established standards for safe, ethical conduct of research.

#### Preamble

The purpose of Rapid Transmission of Knowledge in Science is to contribute to social well-being, health, culture, economic development and the advancements in society. KITS promotes research and innovation as one of their key missions.

#### Scope

This research policy applies to all research conducted by a researcher including under graduate, post graduate students and faculties etc. The primary objective of this policy is to guide the framework for all research activities conducted by the institution. It is imperative that all faculty adheres to the "spirit" and "ethics" of this policy, which emphasizes high levels of professionalism in teaching and supervising.

#### Purpose

All members of the institution who engage in research are expected to follow standards of responsibility and ethical conduct. Further, it ensures that researchers are aware of any changes to the national or international regulatory framework related to research.

# **Objectives of the Research Policy**

- ✓ To improve the research consciousness among faculty by establishing deliberations with renowned researchers and conducting national and international conferences, workshops, seminars, faculty development programmes on research methodology, IPR and patenting.
- ✓ To adhere and support to the highest standards of honesty, integrity and research ethics

- ✓ To publish the research works in renowned journals indexed by Scopus and SCI.
- ✓ Establishing and administering a research fund to enable and support faculty research initiatives and projects.
- ✓ Providing assistance to faculty members in conducting real time research projects that are integrated with the regular curriculum implementation and curriculum enrichment activities
- ✓ Finding and informing potential researchers of appropriate research opportunities announced by academic, research, industry or government organizations
- ✓ Developing and implementing interdisciplinary research methods, including modalities for developing and implementing joint research projects that span more than one knowledge domain, and involving external agencies and experts in these projects
- ✓ Providing researchers with sponsorships for research projects and holding the contributing researchers accountable for the project's success

# Research policy of the institution

Based on the financial provisions available time to time the following support shall be provided;

- ✓ The institute shall offer seed grants to conduct high quality research and to build enthusiastic team with interdisciplinary research goals. The maximum eligible funding for a project is limited to ₹.50,000/-.
- ✓ Proposals will be evaluated by a Research Committee appointed by the principal subject to availability of funds.
- ✓ Research Committee recommendations will be forwarded to the principal for approval and subsequent sanctioning of grants in support of recommended proposals submitted by faculty members.
- ✓ Direct financial assistance will be provided to the Principal Investigator
- ✓ According to the sanction order, the project will start on the date of approval, regardless of when grants are actually released.
- ✓ A maximum of 24 months (2 years) can be allocated to a project.
- ✓ Progress reports and utilisation of funds are to be reported at the end of the six (6) month period.

- ✓ Encourage and support the research publications by the faculty members in refereed journals (SCI/SCOPUS/WOS).
