It has been decided in meeting to educate girl student, teaching and non-teaching women's staff of college about their physical fitness and eating habits and suggested to practice yoga.


It has been decided in meeting for the welfare of the students & women faculty organize interactive sessions for every first night to address the problems.

- 4) Withholding results




